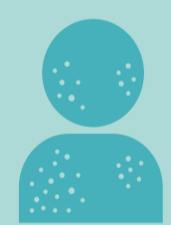

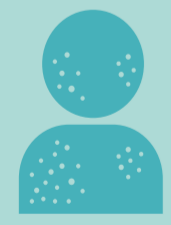
St John Bosco College, Battersea

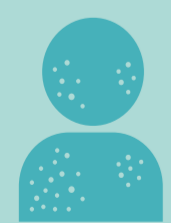
These were the questions that the leadership team at St John Bosco College were asking themselves.



With less and less time for our staff to monitor online activity, how can we protect our students from the challenges and dangers that exist in the online world when the most sophisticated users are often the students themselves?



How can our teachers, many of whom are not necessarily IT specialists, be reasonably expected to constantly manage and monitor ICT use?



Amongst all of the data we see, how can we quickly focus on the more serious type of incidents encountered and find out the details of exactly what is being accessed and simultaneously capture the hard evidence needed to tackle identified problems?



Keeping our children safe is our number one priority when it comes to their use of ICT" says Paul Dunne, Headteacher. "We constantly faced the same issues that all schools face, utilising precious time trying to ensure that our children are protected from malicious or harmful content when online and ensuring that they cannot circumvent the safeguards we have in place to access blocked sites.
